6 **RESOLUTION NO. 2025-003**

8 **A RESOLUTION OF THE ST. GEORGE TRANSITION DISTRICT TO CEASE**
9 **EXISTENCE.**

11 **WHEREAS**, the St. George Transition District (“district”) was created, pursuant to La.
12 R.S. 33:3076, *et seq.*, due to a state of emergency that existed in the municipality until cash flow
13 could be developed through the levy and collection of municipal sales and use taxes to fund the
14 expenses of municipal government.

15 **WHEREAS**, the voters in the City of St. George approved the levy of municipal sales
16 taxes in the election held on December 7, 2024, effective April 1, 2025.

17 **WHEREAS**, the district shall cease existence, and any sales and use taxes levied by the
18 district shall expire at such time as the municipality levies and collects a two percent sales and use
19 tax, the end of the quarter following the election to impose the municipal tax if the proposition is
20 not approved by the electorate, or twelve months after the incorporation becomes final, whichever
21 occurs first.

22 **WHEREAS**, the municipality is levying and collecting a two percent sales and use tax and
23 the incorporation became final on April 26, 2025.

24 **NOW THEREFORE, IT IS RESOLVED** that the St. George Transition District shall
25 cease existence upon the final payment of any obligations and invoices as approved pursuant to
26 Resolution 2024-009.

27 **BE IT FURTHER RESOLVED** by the St. George Transition District Members that this
28 Resolution shall become effective in accordance with law.
