PROPOSED ORDINANCE NO. 2024-

AN ORDINANCE TO AMEND ORDINANCE NO. 2024-015 RELATIVE TO SIGN APPLICATION FEES AND TO PROVIDE FOR RELATED MATTERS

WHEREAS the City of St. George, through Ordinance 2024-002, adopted the St. George Unified Development Code, which included provisions relative to the regulation of signs in the City of St. George and through Ordinance 2024-015, adopted Title 8. Building Codes, which included the adoption of a fee schedule for plan reviews and permit application fees for buildings and related matters; and

WHEREAS the City of St. George desires to add to Appendix A of Title 8 an application fee for signs constructed, installed, or modified within the City.

BE IT ORDAINED by the St. George City Council, State of Louisiana, Appendix A of Title 8 is amended by adding the following:

Section 1. Amendment. Add the following to Appendix A of Title 8 of the St. George Code of Ordinances:
