A resolution authorizing the publication of a notice describing the boundaries of Economic Development District No. 1 of the City of St. George and providing for other matters in connection therewith.

WHEREAS, this Governing Authority now desires to give notice of its intention to hold a public hearing relative to the proposed creation of such an economic development district, and therefore the Act requires the publication of a notice two (2) times expressing the intent to consider the creation of an economic development district; and

WHEREAS, pursuant to the terms of said notice, the creation of Economic Development District No. 1 of the City of St. George (the "***District***") will be considered to provide revenues to assist in funding economic development projects, as defined in the Act, within or about the boundaries of the District, as permitted by the Act.

SECTION 1. In accordance with the Act, the Governing Authority does hereby give notice of its intention to create an economic development district to be called "Economic Development District No. 1 of the City of St. George."

SECTION 3. At the date, time and place mentioned in **Exhibit A** hereto, the Governing Authority will meet in open and public session to hear any objections to the proposed creation of the District and may consider the adoption of an ordinance creating the District.

NOTICE IS HEREBY GIVEN that the St. George City Council (the "***City Council***") proposes to consider the creation of an economic development district to be called "Economic Development District No. 1 of the City of St. George" (the "***District***"), pursuant to the authority of Part II, Chapter 27, Title 33 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 33:9038.31 through 9038.42, inclusive). The public is further notified that the City Council plans to consider the creation of the District and related matters at its regular meeting to be held at 5:00 p.m. on October 13, 2026, at which time the public will be afforded an opportunity to comment upon the creation of the District. As of the publication of this notice, the property contained within the proposed boundaries is not developed and there are no existing commercial structures within the proposed boundaries. Further information regarding the proposed District, including a map of the proposed parcels of property contained within the proposed boundaries, is available during normal office hours at the office of the City Clerk, St. George City Hall, 11207 Proverbs Ave., St. George, La. 70816.
